Working-class women are severely underrepresented in political bodies across the world. We uncover the political significance of class-based representation gaps among women. We theorize and empirically demonstrate how working-class women's distinct socioeconomic circumstances shape their policy priorities, which in turn influence their political efficacy and voting behavior. This research contributes to gender and politics scholarship by illuminating the intersecting class and gender dynamics that structure political representation.
